Programme Foreword: Governance and Purpose

The African Conference on Economic Development and Innovation (ACOEDI 2026) is convened by the Institute for Economic Development and Innovation (IfEDI) in partnership with the International Conference on Business and Management Dynamics (ICBMD). The conference is hosted at Emperors Palace Convention Centre, Johannesburg, in the economic heartland of the Republic of South Africa, and is positioned as a continental platform that links research, policy and industry in service of African prosperity.

This Master Programme for Confirmation has been prepared for circulation to the Conference Governance Council, Board, dignitaries, sponsors and selected stakeholders for comment and input. It serves three purposes: first, to confirm the structure, timing and intent of every conference segment; second, to clarify the strategic roles of government, academia, industry, development finance institutions, chambers of commerce and continental bodies across the four days; and third, to provide a transparent view of presenter capacity, proposed sponsor platforms and indicative dignitary engagement so that all stakeholders can plan their participation with confidence.

ACOEDI 2026 is governed by an independent Conference Governance Council supported by a Scientific and Technical Committee and the Conference Secretariat. Sponsors are positioned as enabling platforms whose contributions are gratefully acknowledged through visibility, hosting and partnership rights. Sponsors do not direct content, awards, peer review or programme decisions. Dignitaries are positioned for legitimacy, strategic direction and continental endorsement. This separation of roles ensures that ACOEDI 2026 retains the institutional credibility expected by government, universities, development finance institutions, corporates, chambers of commerce and continental partners.

The substantive output of the conference will be captured in the African Economic Development and Innovation Atlas 2026, drawing on rapporteur synthesis from every breakaway lab and room. Delegates and presenters are accordingly invited to view their contributions not only as conference inputs, but as part of a permanent continental knowledge record.

How to Read This Programme

This Programme uses a small set of consistent structural elements. The guide below explains each element so that dignitaries, sponsors, delegates and the design and production team can navigate the document with confidence.

PROGRAMME ELEMENT	WHAT IT MEANS
Plenaries	Plenaries are open, high-level sessions for all delegates. They are designed to set strategic direction and provide continental and national framing. Plenaries are chaired by senior conference leadership and feature keynote and high-level panel contributions.
Breakaway Labs (Day 1)	Practical implementation sessions structured around five thematic labs. Each 60-minute block accommodates three presenters, a chair and a rapporteur. Labs are presentation and showcase platforms — not panel discussions by default.
Breakaway Rooms (Day 2)	Knowledge, research and practice sessions running in parallel rooms aligned to the five sub-themes. Each 60-minute block follows the same three-presenter structure, with academic, policy and practice papers represented.
Presenter Slots	Presenter 1, Presenter 2 and Presenter 3 placeholders denote confirmed speaking slots awaiting allocation by the Scientific and Technical Committee following peer review and acceptance.
Dignitary Roles	Dignitary placements indicate the institutional level and seniority required for legitimacy and strategic endorsement. All dignitary allocations are indicative and subject to formal invitation, protocol clearance and governance approval. Named individuals will be confirmed by the Conference Governance Council closer to the event.
Sponsor Platforms	Proposed sponsor platforms identify where sponsor visibility, hosting and partnership rights may be extended. Sponsors are platform enablers; they do not direct content, awards, peer review or programme decisions. All sponsor allocations in this document are indicative and subject to confirmation.
Rapporteurs & Atlas Capture	A dedicated rapporteur is assigned to every breakaway lab and room. Their consolidated outputs feed directly into the African Economic Development and Innovation Atlas 2026.
Standard Session Format	Each 60-minute breakaway block is structured as follows: Chair framing (3 min) → Presenter 1 (12 min) → Presenter 2 (12 min) → Presenter 3 (12 min) → Combined Q&A and synthesis (15 min) → Transition (6 min).
