7 TERMS & CONDITIONS

Payment. Unless otherwise agreed in writing, invoices for equipment, parts and service are due net thirty (30) days from the invoice date. Spectrum Robotics ("Spectrum") may set, change, suspend or cancel any credit limit or terms at its sole discretion.

Deposits. First-time purchasers must pay a deposit on each order before equipment ships or installation is scheduled, in the amount stated on the quote or order confirmation. Spectrum may require a deposit from any customer at its discretion, including for custom orders or large-volume purchases. Deposits are applied to the final invoice and are non-refundable once equipment has been ordered from the manufacturer, except as the order confirmation states otherwise.

Late charges. Past-due balances accrue a late charge of 1.5% per month (18% per year) or the highest rate permitted by law, whichever is lower. Applicant agrees to pay reasonable costs of collection, including attorneys' fees and court costs.

Leases & RaaS. Lease financing and Robots-as-a-Service subscriptions are governed by a separate lease or subscription agreement and may require approval by Spectrum's financing partners. Approval of this application does not by itself create a lease or subscription.

Title & security interest. Title to purchased equipment passes to Applicant only upon payment in full. Applicant grants Spectrum a purchase-money security interest in equipment sold on credit until paid, and authorizes Spectrum to file UCC financing statements.

Credit investigation. Applicant authorizes Spectrum and its financing partners to investigate the credit information given here, to contact the bank and trade references listed, and to obtain business and consumer credit reports on the business and any guarantor. Applicant authorizes those references to release information to Spectrum.
