Hedge Funds:

Hedge funds are collective investment schemes with a strategy that allows for leveraging and short-selling strategies. Hedge fund strategies can result in losses greater than the market value of the fund, but investors' losses are limited to the value of the investment or contractual commitments. Hedge funds can also be invested in illiquid instruments. While CIS in Hedge Funds differ from CIS in Securities (long-only portfolios), the two may appear similar, as both are structured in the same way and are subject to similar regulatory requirements.

A manager may, in exceptional circumstances, suspend repurchases for a period, subject to regulatory approval, to await liquidity and the manager must keep the investors informed about these circumstances.
