GROW program participants graduate with a Certification in SCRATCH Coding-one of the leading developmental coding languages, currently taught in over 200 countries. BCAUSEICAN RISE - Provides computer coding instruction to middle school students. RISE program participants graduate with a Certification in PYTHON Coding-the leading coding language in the Information Technology industry, used in Data Science and Cybersecurity. BCAUSEICAN SOAR - Provides coding instruction to high school students. SOAR program participants graduate with a Certification in Cloud Computing, PYTHON, or JAVA Coding-all highly sought after in the job market, which allows students to secure internships and jobs in the industry ahead of their counterparts. BCAUSEICAN THRIVE - Program for adults and seniors offers technology workshops classes. These classes are typically held in the evening for one hour each week. Training is customized based on need and covers topics ranging from learning how to create an email account, to more advance training on how to use applications like ParentVue, Google Classroom, Class Dojo, Google Meet, Microsoft Office, and Zoom. BCAUSEICAN TEACH - Provides a highly engaging hands on full-day training to teachers and school administrators that
