



EXCLUSIVE BEAT LICENSE AGREEMENT

This Exclusive Beat License Agreement ("Agreement") is entered into on the date of purchase by and between **Song Foundry** ("Producer") and the purchasing party ("Artist"). By purchasing and downloading the instrumental/beat from Song Foundry, Artist agrees to the following terms:

1. GRANT OF RIGHTS

Producer grants Artist an exclusive license to use the instrumental composition ("Beat") for commercial and non-commercial purposes worldwide. Once sold exclusively, the Beat will be removed from public sale and no additional exclusive licenses will be issued. Any previously issued lease licenses remain valid until their expiration date.

2. TERM

This Agreement shall remain in effect indefinitely unless terminated due to breach of contract.

3. OWNERSHIP

Producer remains the sole owner of the underlying instrumental composition and sound recording unless otherwise agreed in writing. Artist owns: • 100% of the new vocal composition/lyrics created by Artist • The final master recording, subject to Producer's retained participation outlined below

4. MASTER ROYALTY / POINTS

Producer shall retain: • 5% ownership interest in the final master recording • 5 producer points (5% of net master revenue) Artist shall retain: • 95% ownership interest in the final master recording

5. PUBLISHING & SONGWRITING SPLITS

Artist shall receive: • 100% of the Writer's Share • 75% of the Publisher's Share Song Foundry shall receive: • 25% of the Publisher's Share This structure allows Artist to retain full songwriter income while Producer only participates on the publishing side.

6. TV / FILM / SYNC USE

Any television, film, trailer, commercial advertisement, or major sync placement involving the composition or master recording shall require a separate written synchronization agreement approved by both Producer and Artist before final authorization. No party may independently approve a TV, film, or major sync placement without written consent from the other party.

7. USAGE RIGHTS

Artist may: • Record vocals over the Beat • Distribute commercially • Upload to streaming services • Perform live • Create music videos • Monetize on YouTube and social media

8. CREDIT

Artist agrees to provide reasonable credit where commercially practical using one of the following: • “Produced by Song Foundry” • “Prod. by Song Foundry”

9. PROHIBITED USES

Artist may NOT: • Resell the Beat by itself • Claim sole production ownership of the Beat • Transfer this license to another party without written permission

10. GOVERNING LAW

This Agreement shall be governed by the laws of the State of Alabama, United States.

11. ACCEPTANCE

By purchasing, downloading, or using the Beat, Artist acknowledges that they have read, understood, and agreed to the terms of this Agreement.
