For families using PEP or UA Direct Bill: any portion of tuition or enrollment fees not covered by your scholarship is your direct financial responsibility. Delays, denials, or changes in scholarship funding do not reduce or eliminate your obligation under this agreement.

SECTION 5: SEAT RESERVATION & FULL-TERM COMMITMENT

THIS IS A BINDING FINANCIAL COMMITMENT FOR THE FULL 9-WEEK TERM.

By enrolling your child at Creative Connections Learning for Term 2 (October 12 – December 17, 2026), you are reserving a seat in your child's grade band for the entire term. Once the term begins, that seat is held exclusively for your child and cannot be offered to another family. Your tuition covers the cost of that reserved seat for the full 9-week term.

Full tuition is owed for the entire term regardless of whether your child attends every class, whether you choose to withdraw or discontinue during the term, whether your family's schedule or circumstances change, or for any other reason.

Specifically, this means:

1. If your child enrolls and you later decide CCL is not the right fit, **you still owe the full tuition for the term.**
2. If your child stops attending for any reason during the term, **you still owe the full tuition for the term.**
3. If your child is removed from the program due to behavior, **you still owe the full tuition for the term.**
4. **No refunds, credits, prorated adjustments, or carryovers to future terms will be issued once the term has begun.**
5. The enrollment fee is non-refundable under all circumstances.
6. If you withdraw your child during the term, the remaining balance on your payment schedule is still due and payable on the original dates.

This policy exists because CCL is a small program. Class sizes are limited, staffing is planned around enrollment, and materials are purchased for the term. When a family enrolls and then leaves mid-term, the financial impact on the program is significant and cannot be recovered.

SECTION 6: LATE PAYMENT & NON-PAYMENT

If a payment is not received within 7 days of its due date, the account will be considered past due. **Students with a past-due account may not attend class until the balance is brought current.**

Families with an unpaid balance from a current or previous term will not be eligible to enroll for future terms until the balance is resolved.

CCL reserves the right to pursue collection of any unpaid balance owed under this agreement.

SECTION 7: ACKNOWLEDGMENT OF TERMS
