

INTELLECTUAL PROPERTY, CONFIDENTIALITY, OWNERSHIP & NON-USE AGREEMENT

The Participant, Contractor, Vendor, Sponsor, Speaker, Volunteer, Student, Client, Partner, Affiliate, Member, Exhibitor, Honoree, Employee, Consultant, or Representative ("Participant") acknowledges and agrees that all intellectual property, proprietary information, confidential information, trade secrets, business methods, systems, processes, programs, publications, educational materials, curricula, course content, certifications, training materials, recordings, photographs, videos, media assets, databases, websites, software, artificial intelligence systems, prompts, workflows, automations, CRM configurations, branding elements, logos, trademarks, service marks, trade names, event concepts, business models, strategic plans, documents, presentations, templates, forms, methodologies, operational systems, and all derivative works created, owned, licensed, developed, or utilized by Trinity International University of Ambassadors Corporation (TIUA), TIUA School of Business, SurvivorX™, Trinity Girls Network Corp., Influence Authority™, Mpowered Media Solutions, Crown100 Media Network, and any affiliated entities (collectively referred to as the "Organization") are and shall remain the sole and exclusive property of the Organization.

- (c) Create, establish, operate, assist, promote, or support any competing organization, educational institution, certification program, event, media platform, coaching program, consulting practice, conference, publication, training system, artificial intelligence platform, membership community, or substantially similar business model utilizing information obtained through the Organization;
- (d) Represent, imply, or suggest ownership, partnership, authorization, endorsement, certification, affiliation, or sponsorship by the Organization without express written authorization.

All work product, contributions, recordings, presentations, publications, interviews, testimonials, articles, educational content, media content, graphics, digital assets, software configurations, artificial intelligence prompts, systems, frameworks, and materials created, submitted, developed, or provided in connection with the Organization shall be deemed a Work Made for Hire and shall become the sole and exclusive property of the Organization. To the extent any such work is not legally considered a Work Made for Hire, Participant hereby irrevocably assigns all rights, title, and interest in such work product to the Organization.

The Participant further agrees that all confidential, proprietary, strategic, financial, operational, technological, educational, organizational, and business information disclosed by the Organization shall remain confidential and shall not be disclosed to any third party without prior written consent.

These obligations shall survive termination, resignation, graduation, completion of services, expiration of any agreement, cancellation of participation, or the end of any relationship with the Organization and shall remain in effect indefinitely.

The Organization shall be entitled to seek injunctive relief, specific performance, monetary damages, attorney's fees, court costs, and all remedies available at law or in equity for any violation of this provision.

The Participant acknowledges that unauthorized use or disclosure of the Organization's intellectual property or confidential information may cause irreparable harm and agrees that immediate legal and equitable remedies may be pursued without further notice.
