All findings come from public records: county hearing video, the proffer documents themselves, published news reporting, the foundation's own slide deck filed in the School Board's public BoardDocs library, the county's own rezoning packets, and — new in this version — the primary corporate filings of every Musical Creations entity, pulled directly from the Virginia State Corporation Commission's public Clerk's Information System. No FOIA response, leak, or private source is required for any claim in this document.

This report organizes public records for informational and evidence-organization purposes only. It is not legal advice.

1 | THE ANSWER

The \$25,000 Musical Creations Foundation provision was drafted, structured, and submitted by Luck Stone Corporation through its counsel, Charles W. Payne Jr. of Hirschler Law. This is proven by Luck Stone's own admission of structuring, by the proffer document itself, and by every other party's written denial.

The foundation's own records — recovered September 9, 2026 from the School Board's public BoardDocs library — now show who was on the receiving end: the Planning Commissioner himself is listed as a foundation board member in the foundation's own March 2026 impact report, and a second board member stood up at the July 23 hearing to thank Luck Stone for the \$25,000 in public comment.

New in this version: the primary state filings pulled from the SCC Clerk’s Information System (September 10, 2026) establish two further facts. First, the 2019 founding documents of Musical Creations Unlimited L.L.C. describe J.D. Young himself as a member or manager of that company, at his own Richmond home address. Second, every sworn annual report of the foundation — through the one filed August 3, 2026 — lists only his wife as director and officer, while the foundation’s own deck lists four board members including the Commissioner. The contradiction between the deck and the sworn state record is documented in Section 6.

On September 8, 2026, the Board of Supervisors declined to discipline Commissioner Young, who denied any wrongdoing. The Board’s decision resolves the discipline question — it does not resolve the central factual question of who first requested the provision.

2 | THE PROOF — NINE PUBLIC SOURCES

PROOF 1 — Payne’s own words at the July 23 public hearing

Spoken by Payne at the Caroline County Planning Commission public hearing, recorded on the county’s YouTube video, quoted verbatim by the Fredericksburg Free Press (July 24, 2026, Taft Coghill Jr.):

“The way we structured this was to help music education with the school system, and we understand the foundation works with the schools. So, we left it up to the school system to make that determination.”

“We” = Luck Stone / Payne’s team. He attributes the structuring of the provision to the applicant. Spoken on the record, at a public hearing, recorded on video.

PROOF 2 — Payne’s statement to the press (August 8, 2026)

“The inclusion of the Musical Creations Foundation in the proffer reflected one potential avenue for advancing music education... That approach reflects Luck Stone’s longstanding commitment...”
(Free Press, Aug 8, 2026)

The inclusion is Luck Stone’s approach, per their own counsel.

PROOF 3 — The proffer document itself

The provision appears in Luck Stone’s own submission (July 23 packet, pp. 52, 60), drafted by their counsel.

PROOF 4 — Every other party denied requesting it, in writing

Toneika Stephens-Young (written statement, Aug 8, 2026, via Free Press): the foundation “did not draft, request, author, or propose the language contained within the developer’s voluntary proffer statement... This language was solely the developer’s proposal.”

J.D. Young (July 23 hearing + text message to Free Press): the proffer “doesn’t involve him... he’s not involved with the foundation.”

CCPS (July 31, 2026 letter, Supt. April L. Calveric / board chair): the school division has no partnership or agreement with MCF and asked the county to clarify the record.

PROOF 5 — The foundation's own presentation to the School Board (July 13, 2026)

Recovered from CCPS BoardDocs. Slide 10 (the Black College Expo impact report, dated March 28, 2026):

"MCF Board Members attended: Jezmon Lewis, Toneika Young, JD Young, and Scott Johnson."

J.D. (Juan) Young	MCF board member — listed in the March 28, 2026 impact report (deck slide 10)	Planning Commissioner — sat on the July 23 hearing without recusal, saying "It doesn't have anything to do with me"; abstained Aug 27

The foundation's own board list connects the commissioner, the named beneficiary organization, and the public speaker who lobbied for the money.

What the deck does not contain: no mention of Luck Stone, the quarry, or RZ-06-2024 anywhere in its 17 slides. It does not prove who first suggested the foundation's name to Luck Stone or Hirschler — that remains inside the pre-May-13 drafting chain. It proves who was on the receiving end, and that they knew and lobbied.

PROOF 6 — The money: MCF's own budget vs. the proffer

Slide 12 of the July 13, 2026 deck discloses the foundation's own finances:

The \$25,000 proffer would have nearly **doubled the foundation's entire annual budget** in a single payment — covering its \$12,908 gap nearly twice over. The deck's sponsorship list includes Durwood Young and Barbara Johnson. Slide 3 names Toneika Stephens-Young as Founder and CEO; slide 9 signs her as Executive Director.

PROOF 7 (NEW) — The sworn state record: the SCC annual reports

Pulled September 10, 2026 from the SCC Clerk's Information System (public). Every annual report the foundation ever filed — AR2024 (filed Feb 5, 2025), AR2025 (filed Sept 2, 2025), and AR2026 (filed Aug 3, 2026) — lists the same board:

No J.D. Young. No Scott Johnson. No Jezmon Lewis. The sworn state record names **only the commissioner's wife**, in every year, through the report filed five days before the proffer removal. See Section 6.

PROOF 8 (NEW) — The 2019 founding documents: J.D. Young as member or manager

The Articles of Organization of Musical Creations Unlimited L.L.C., filed April 30, 2019 (SCC filing 1904580669), state in the filed text:

“The name of the limited liability company's initial registered agent is Juan Durvell Young. The initial registered agent is an individual who is a resident of Virginia and a member or manager of the limited liability company.”

The same filing gives the company's registered office as **109 Colter Drive, Richmond, VA 23223** — described as “identical to the business office of the initial registered agent” — and the SCC's own receipt letter is addressed to “JUAN DURVELL YOUNG, 109 COLTER DRIVE, RICHMOND, VA 23223.” The organizer who signed was Toneika Stephens. See Sections 7 and 8.

PROOF 9 (NEW) — The serial-cancellation and reinstatement record

All three Musical Creations entities were repeatedly auto-canceled for non-payment and reinstated — and on **February 5, 2025, all three were reinstated on the same day**, the same month the foundation's IRS tax exemption was issued. See Section 7 for the full table.

Wording discipline: the named \$25,000 provision was removed after the conflict became public, while the school-facilities proffer rose by the same \$25,000. The removal and the increase are documented facts; the reason for the removal is not. Likewise the auto-cancellations are administrative (fee non-payment); the pattern and timing are stated without any claim of intent.

4 | THE BOARD’S DECISION (SEPT 8, 2026) AND THE ACCOUNTABILITY QUESTION

On September 8, 2026, after a weeks-long public controversy, a roughly 2h40m closed session on possible discipline (Aug 20), and a Planning Commission denial of the project itself (Aug 27), the Caroline County Board of Supervisors **declined to discipline Planning Commissioner J.D. Young**. Young denied any wrongdoing in Luck Stone’s \$25,000 proffer to the nonprofit owned by his wife. (Fredericksburg Free Press, Sept 9, 2026, Taft Coghill Jr.)

This decision resolves the discipline question. It does not answer, and does not claim to answer, the central factual question of this file:

“Who first asked that Musical Creations Foundation be named in the May 13, 2026 proffer draft?”

That leaves the Board with a public accountability question that follows directly from its own decision:

“If the Board declined discipline, what factual finding did it make about who requested the \$25,000 provision, and what evidence did it rely on?”

If the Board’s answer is...	Then the public record shows...
“We did not determine who requested it”	The Board declined discipline while the central factual question remained unresolved.
“We determined who requested it (or that no one did)”	The underlying records and evidence exist somewhere — and are producible.

Either answer is documented evidence. The question can be put in writing to the Board, and the closed-session motion, certification, and any written legal advice concerning discipline are the natural next records to request.

Note: the Free Press’s own subhead now characterizes Musical Creations Foundation as “the nonprofit owned by his wife” — the ownership relationship is now uncontested in public reporting. The sworn SCC filings go further: they show Toneika Stephens-Young as the **only** officer and director the foundation has ever disclosed to the state (Section 6).

5 | THE CHURCH LAYER — WHO ELSE IS INSIDE THE PROJECT

The county’s own rezoning packets show that the community-benefit environment around RZ-06-2024 was wider than the two cash proffers. The project’s Owner group is not Luck Stone alone:

In addition, Oxford Mount Zion Baptist Church’s leaders and congregants participated in the July 23 public hearing in support of the project, citing promised benefits. The church-benefit chain and the Musical Creations chain were operating inside the same community-benefit environment, before the same commission, in the same window of time.

This does not establish that any church requested that Musical Creations Foundation be included in the proffer. What it establishes is a concrete, named group of parties and communications to search: Luck Stone / Hirschler correspondence involving Young, Stephens-Young, Musical Creations, the Carmel School, or the OMZBC trustees; county staff emails predating May 13; and every draft of the proffer — specifically the redline on which “Musical Creations Foundation, Inc.” first appears.

Verification note: “Jericho” appears in the county packets only as Jericho Road, a physical road — no “Jericho Baptist Church” appears in either packet. Any church-benefit claim beyond the OMZBC and Carmel School items above is unverified.

6 | NEW: THE SWORN STATE RECORD vs. THE FOUNDATION'S OWN DECK

The foundation's July 13, 2026 slide deck and its sworn SCC annual reports cannot both be accurate about who runs the organization:

The Virginia annual report form carries its own warning, printed on the face of every filing:

"It is a Class 1 misdemeanor for any person to sign a document that is false in any material respect with intent that the document be delivered to the Commission for filing."

Only one of two things can be true, and the public record now documents the contradiction either way:

The sworn reports are accurate — Toneika is the only director and officer	Then the deck's "MCF Board Members" list (presented to the School Board on July 13, 2026, ten days before the hearing) named the Commissioner and Mr. Johnson as "board members" of an organization whose governing board, per the state record, includes neither of them.

Wording discipline: this section documents a contradiction between two public records. It makes no claim about which document is inaccurate, about intent, or about any person's state of mind. The contradiction is the finding.

7 | NEW: THE ENTITY STACK — THREE ENTITIES, ONE HOME ADDRESS

Three Musical Creations entities have existed. All three have been registered at 26762 Oxford Rd, Ruther Glen — the Young family home, on the same road as the Luck Stone project. Every fact in this section is from the primary SCC filing, pulled September 10, 2026 from the public Clerk's Information System (11 exhibits, publicly hosted).

The auto-cancellations are administrative events caused by unpaid fees; the pattern and its timing are stated as documented facts only, without any claim of intent. The Feb 5, 2025 cluster is a matter of public record: one day, three filings, one signer on all of them — Toneika Stephens-Young.

8 | NEW: THE RICHMOND ORIGIN — 109 COLTER DRIVE

The 2019 LLC’s founding documents place J.D. Young’s business address at his own home at 109 Colter Drive, Richmond, VA 23223 — a 1,440 sq ft townhouse in the Saint Claire Ridge development, Henrico County, built 2009. The SCC’s April 30, 2019 receipt is addressed to him at that address. The property trail matches a relocation to Caroline County:

What this establishes: the Musical Creations operation began as a Henrico County home-based business in April 2019, with the commissioner himself as its registered agent and, per the filed articles, a member or manager. The family's move to Caroline County — to Oxford Road, the same road the Luck Stone project sits on — occurred between the April 2021 sale and the March 2022 filing.

What this does NOT establish (stated plainly):

The public MLS record does not name the seller or buyer of 109 Colter Drive. Whether J.D. Young held the deed or rented is not proven by the sources in this file; the deed itself would settle it. What is proven by primary documents is that he lived there (SCC's own receipt addressed to him at the property) and that the sale date aligns with the family's relocation. No ownership claim should be made without the deed.

Residency note (for completeness, stated neutrally): a 2021–2022 move means Young has lived in Caroline County roughly four to five years by the November 2026 election — he meets any district residency requirement for the Reedy Church Board of Supervisors seat he is seeking. The Henrico chapter is context for the entity timeline, not an eligibility challenge.
